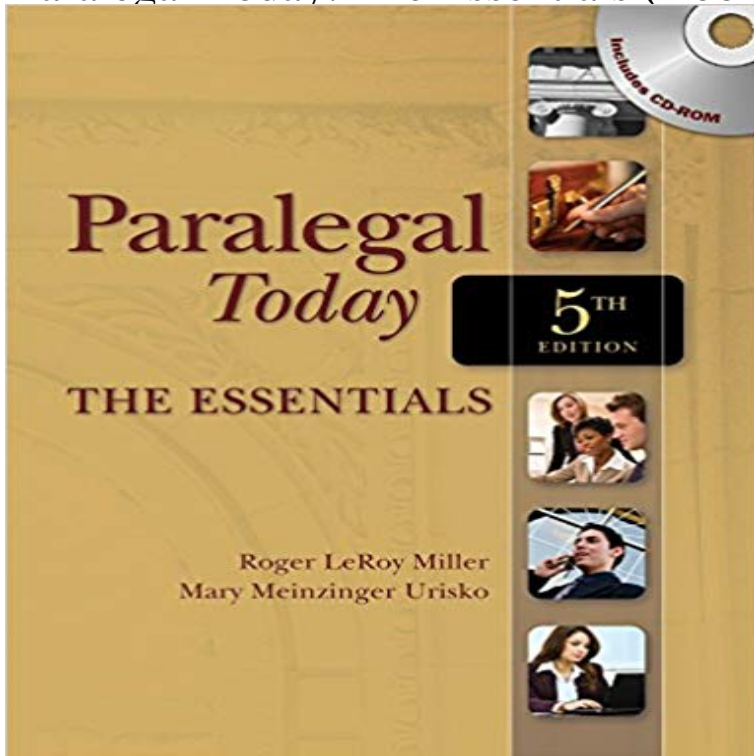


## Paralegal Today: The Essentials (Book Only)
