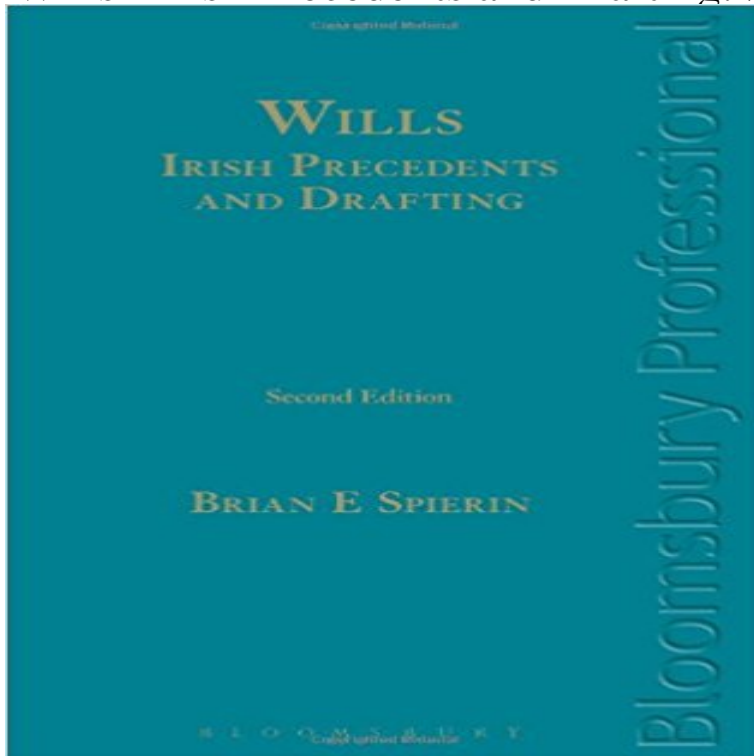


## Wills - Irish Precedents and Drafting: Second Edition

Primarily a practical precedent book, but containing much more than just precedents, this book will prove invaluable to all legal practitioners specializing in Irish probate and succession law. Most chapters cover a constituent part of a will, and the book includes a commentary which summarizes the applicable law and gives advice on matters to be taken into consideration, as well as the pitfalls to be avoided. Clear and concise, the Irish precedents are drafted in a straightforward modern style and annotated where necessary. Full appendices are included, containing the relevant statutory provisions, which will be of use to the practitioner when drafting a will.
