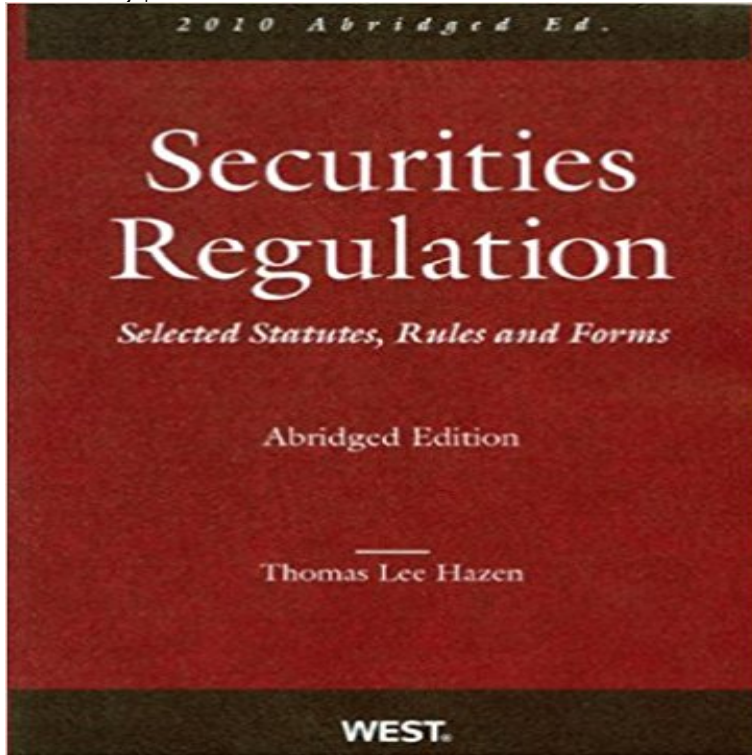


# Securities Regulation, Selected Statutes, Rules and Forms, 2010 Abridged Edition
