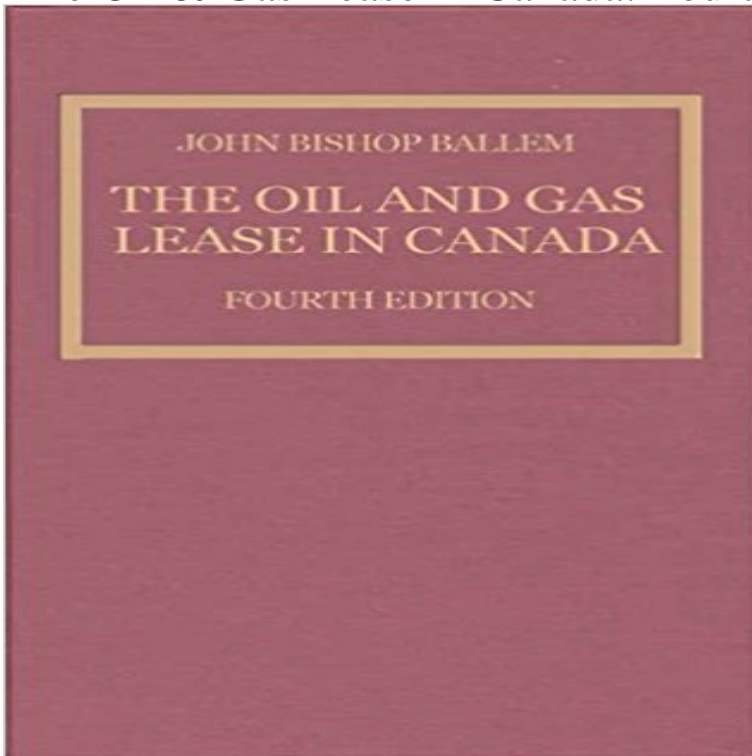


The Oil & Gas Lease in Canada: Fourth Edition

Ballem deals with specific examples of this situation, detailing its consequences for both individual mineral owners and companies, as well as for future judicial pronouncements.
