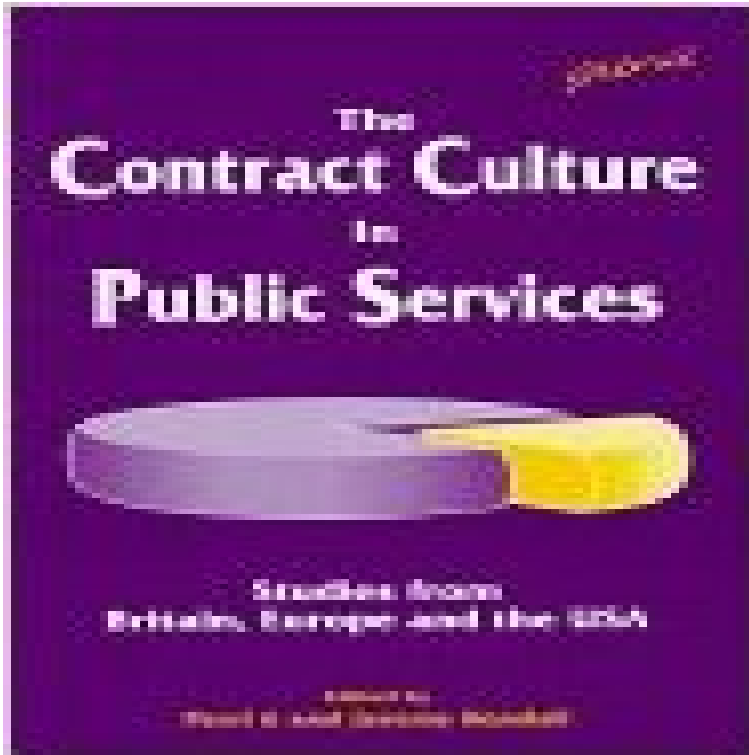


The Contract Culture in Public Services: Studies from Britain, Europe and the USA
