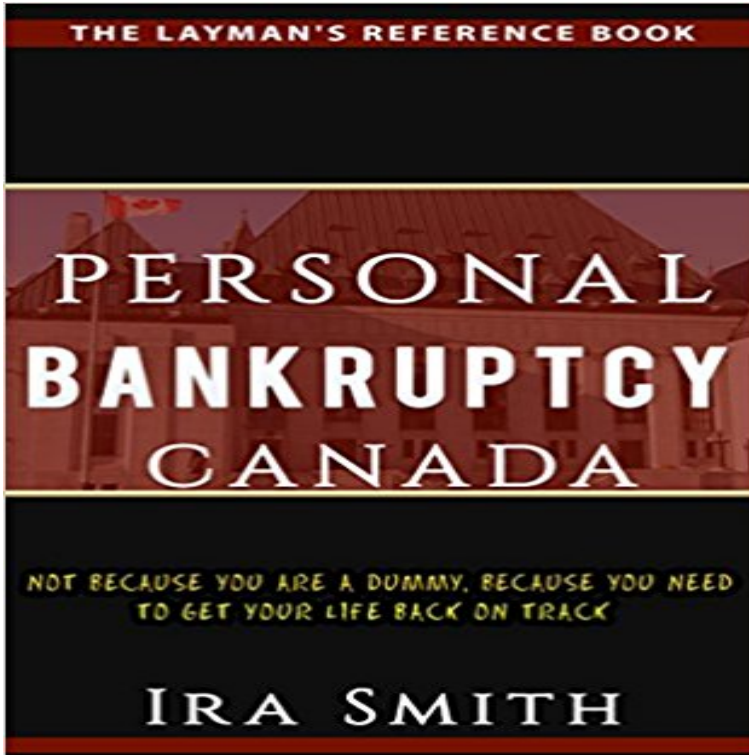


Personal Bankruptcy Canada: Not Because You Are A Dummy, But Because You Need To Get Your Life Back On Track
