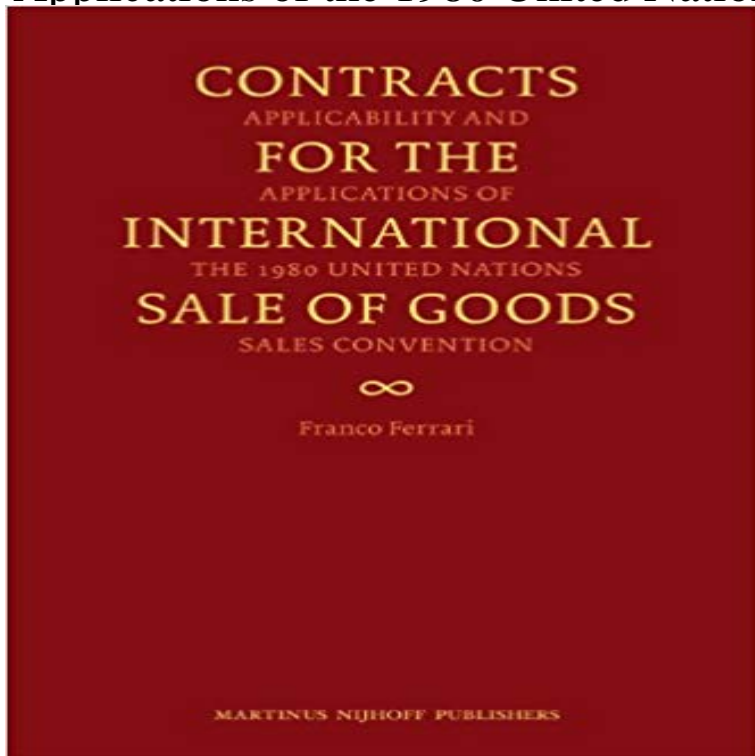


# Contracts for the International Sale of Goods: Applicability and Applications of the 1980 United Nations Sales Convention
