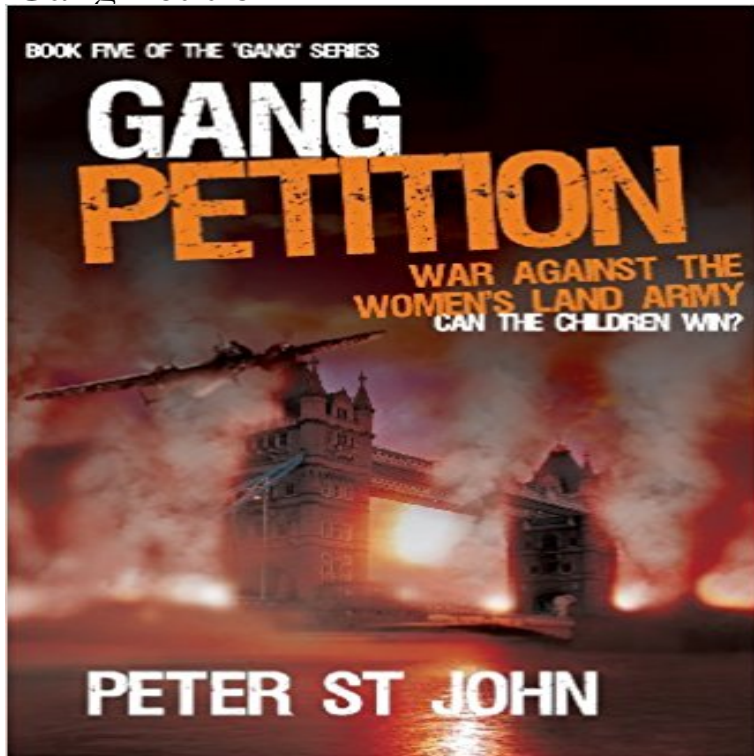


## Gang Petition
