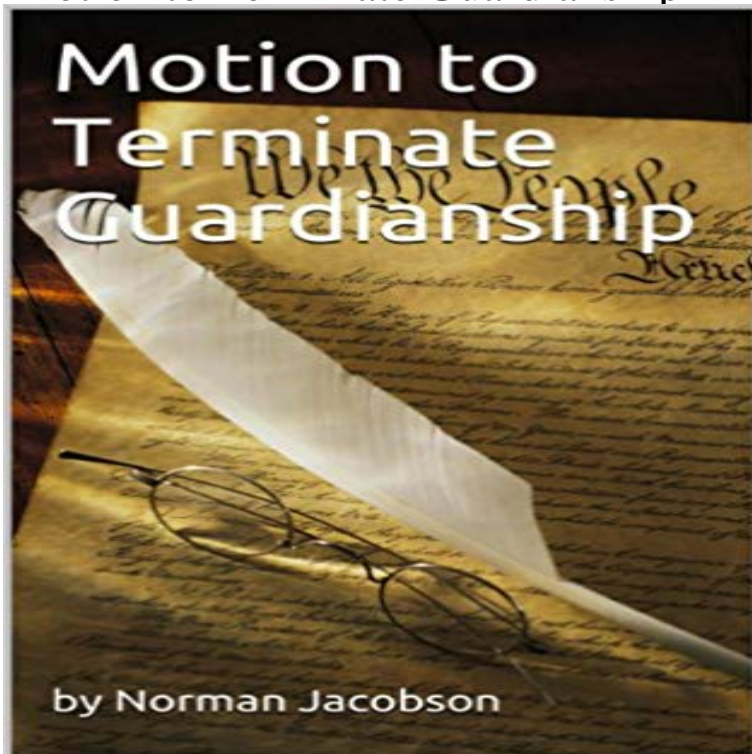


## Motion to Terminate Guardianship



This is an attempted motion to rescue Sheri from the cruel inhumane Intentional Infliction of Severe Mental Distress. On Jan 9, 1997, Attorney Amy allegedly committed fraud and deceit on the court to obtain possession of Sheri so that she could secretly transport Sheri around the country and keeping her at secret locations for the de-facto purpose of evading law enforcement and court visitors. This is known as SMUGGLING. And is a criminal offense in Texas. As a consequence of Attorney Amys efforts to deny Sheri the protection of the Court and the laws of Texas, Sheri was allegedly abused so severely by her captors alleged abuses that she could not walk for a year. Attorney Amy was allegedly committing felony perjury to prevent the investigations of Court Visitors. Attorney Amy allegedly won the favor of here supervising Judge by having the Judge perform a marriage ceremony in San Antonio, TX on Halloween 1998. A few days later on Dec 15, 1998, Attorney Amy demanded that her alleged niece be crushed with the Intentional Infliction of Severe Mental Distress of Isolation from family, friends, court visitors, and law enforcement allegedly as punishment in retaliation to Senator Judys request for an abuse investigation that Attorney Amy evaded by secretly transporting Sheri to a secret location out of sight of the law enforcement agency that was recommended to investigate the alleged abuse by Attorney Amy. . Attorney Amy took advantage of Judgement after Sheri was secretly punished without trial by leaving the state for one and a half years concealing were Sheri was and concealing were Attorney Amy was. For 12 years Attorney Amy secretly transported Sheri around the country to secret locations evading court visitors and evading law enforcement. Attorney Amy allegedly enlisted Patrick and Mary to aid and abet

her in her efforts to evade Court Visitors and thereby deny Sheri the protection of the Texas abuse laws. The alleged crime spree of evading court visitors, transporting Sheri secretly around the country, to secret locations (allegedly pretending to commit Human Trafficking) continued for 12 years before an attorney caught up with her and told her On Oct 19, 2010, that he found incriminating evidence in the court files and that she had better resign. On Oct 20, 2012 Attorney Amy agreed to resign and asked that her friends at Family Eldercare take her place and that he should refuse to prosecute Maries application to be guardian. According to sworn testimony, Attorney Amy was visiting Sheri once a week during the time Amy was allegedly preventing Court Visitors from visiting Sheri, by allegedly ordering Patrick and Mary to conceal Sheris address, Attorney Amys address from the court and to prevent Court Visitors. The alleged co-conspirators of Attorney Amy are now allegedly acting as co-conspirators of Betty and are vigorously Intentionally Inflicting Severe Emotional Distress purportedly Sheri abused the staff at her secret home that was in either San Antonio, TX, San Marcos, TX, Austin, TX, Round Rock, TX, or some other city, and some other state. Purportedly Attorney Amy was allowed to conceal Sheris address from the court and I was told that the Court in San Antonio, TX did not know were Sheri was staying then. Purportedly the purpose of concealing Sheris address from the court was to aid and abet Attorney Amy in contempt of court as, Attorney Amy had been ordered to keep Sheri in the San Antonio, Bexar County, TX area.
