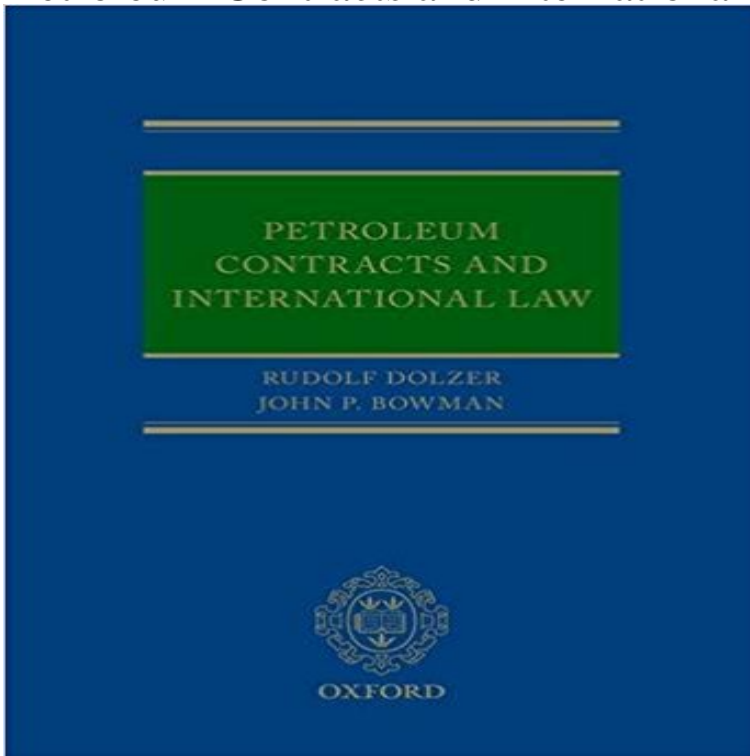


Petroleum Contracts and International Law
