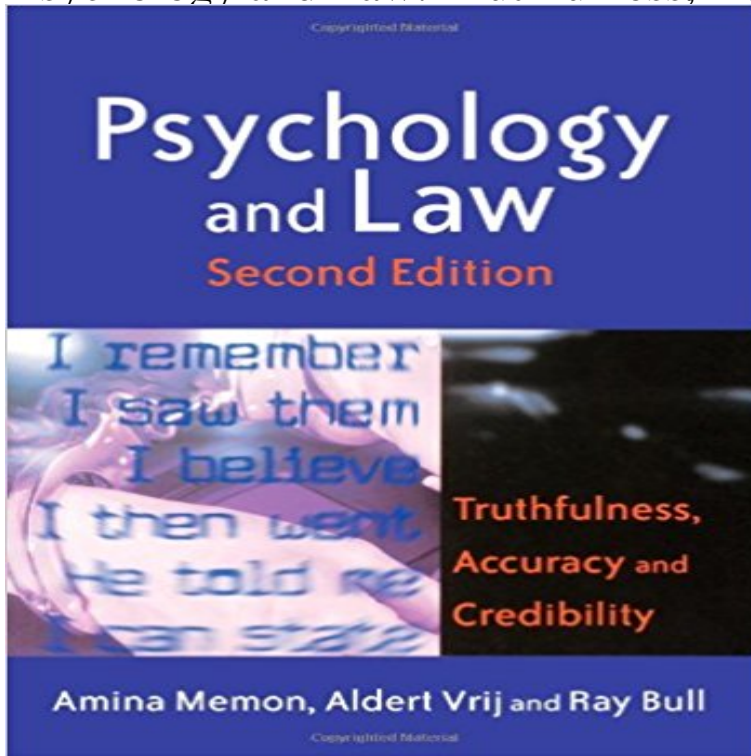


Psychology and Law: Truthfulness, Accuracy and Credibility
