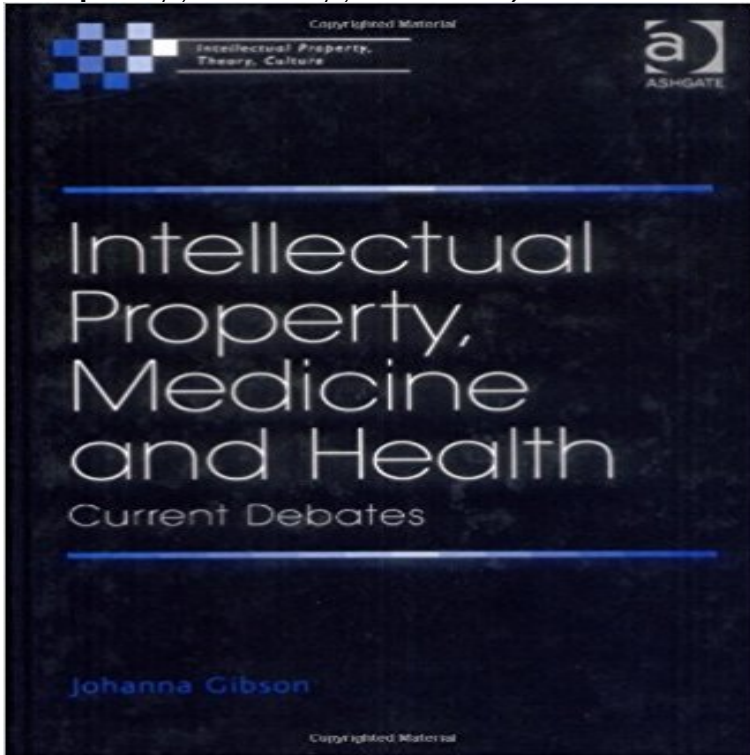


# Intellectual Property, Medicine and Health: Current Debates (Intellectual Property, Theory, Culture)
