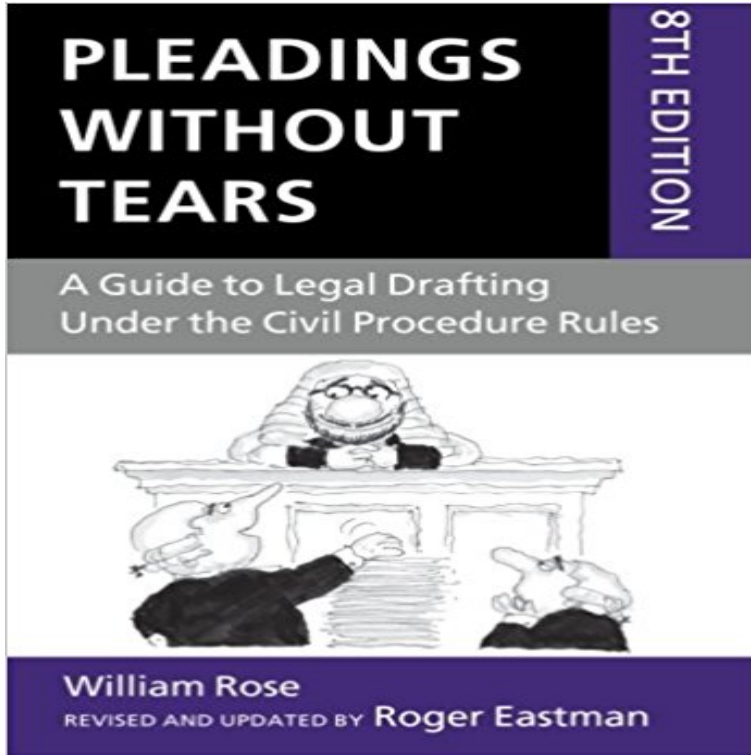


# Pleadings Without Tears: A Guide to Legal Drafting Under the Civil Procedure Rules
