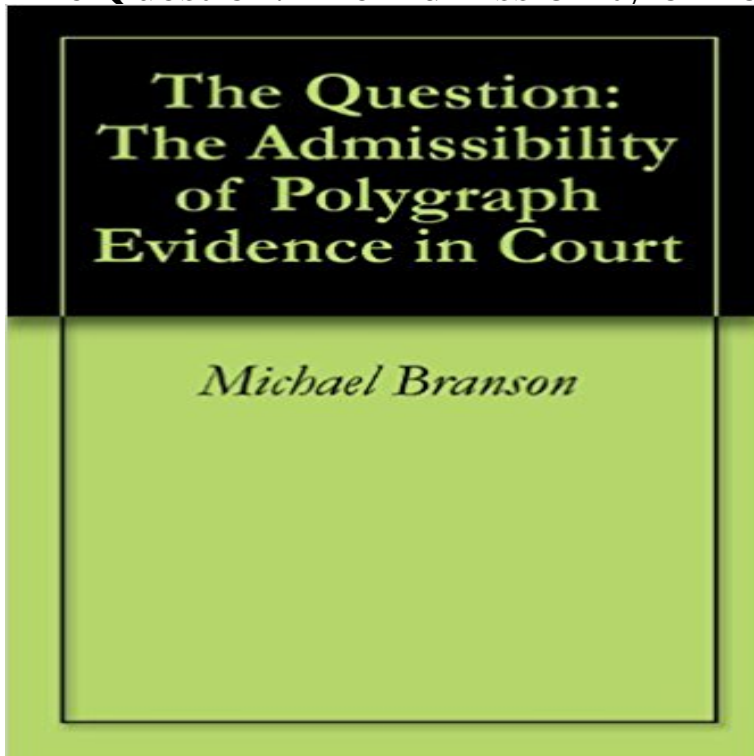


## The Question: The Admissibility of Polygraph Evidence in Court
