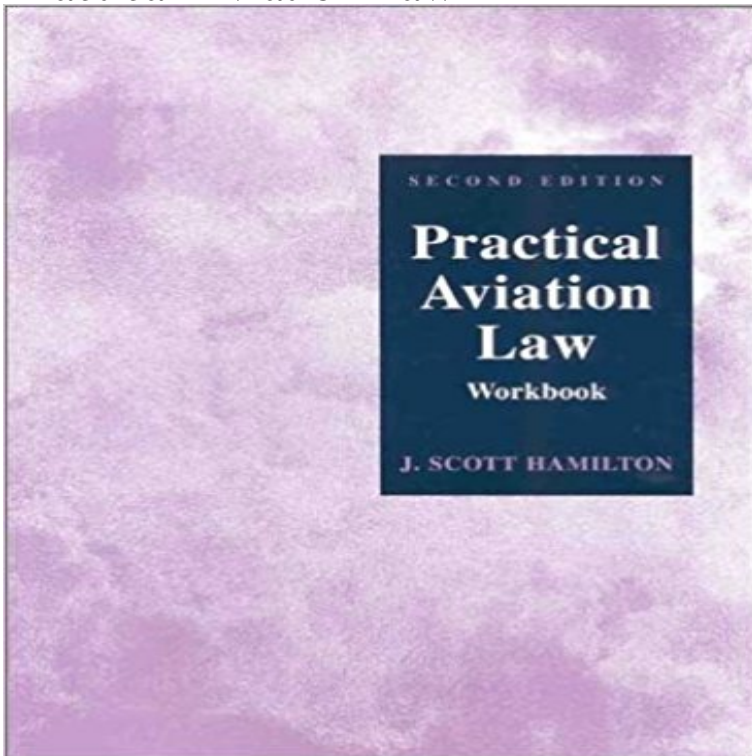


Practical Aviation Law
