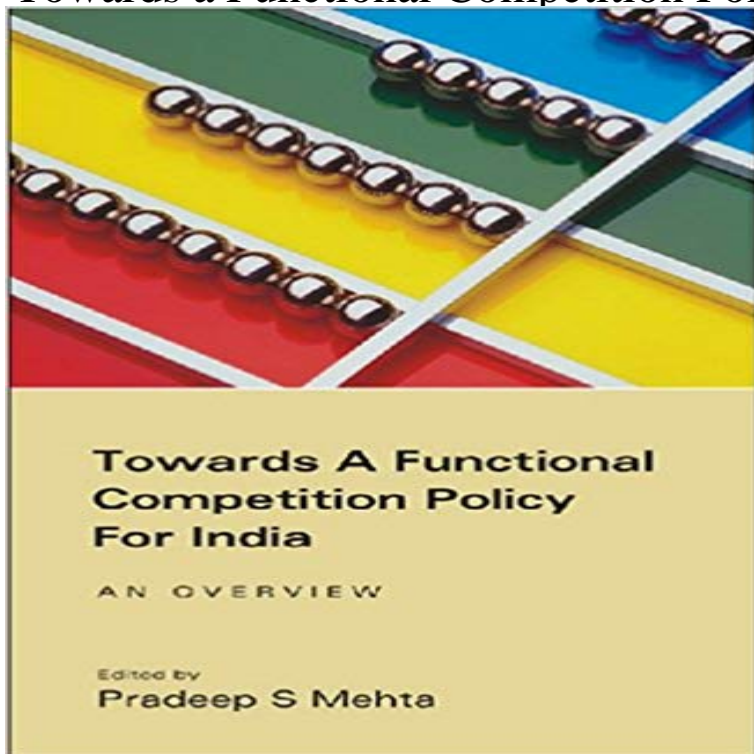


Towards a Functional Competition Policy for India: An Overview
