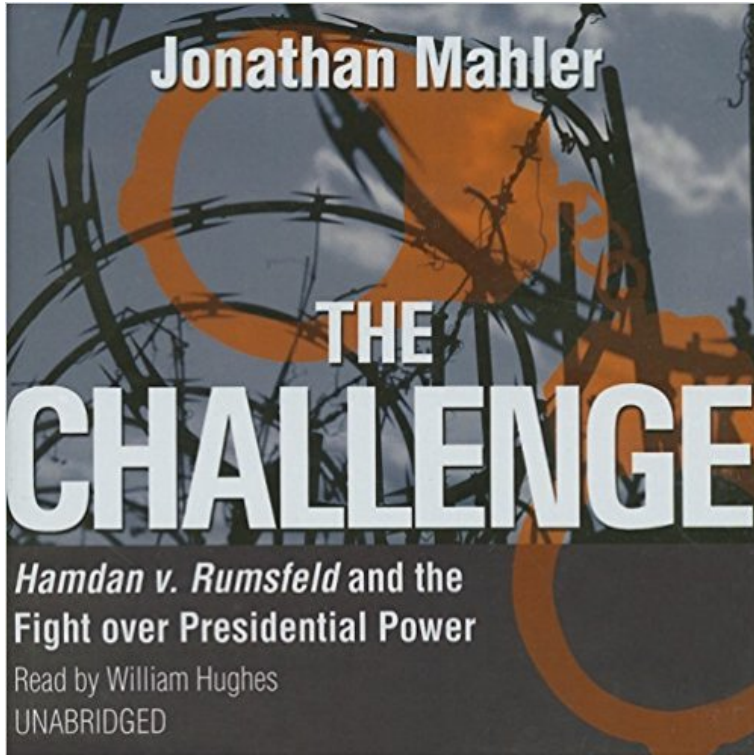


# The Challenge: Hamdan v. Rumsfeld and the Fight over Presidential Power
