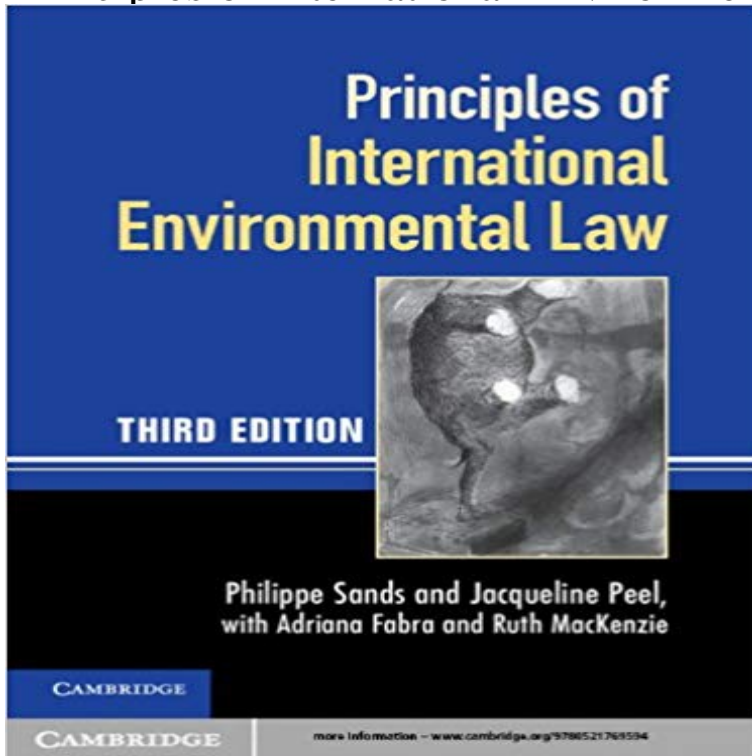


# Principles of International Environmental Law
