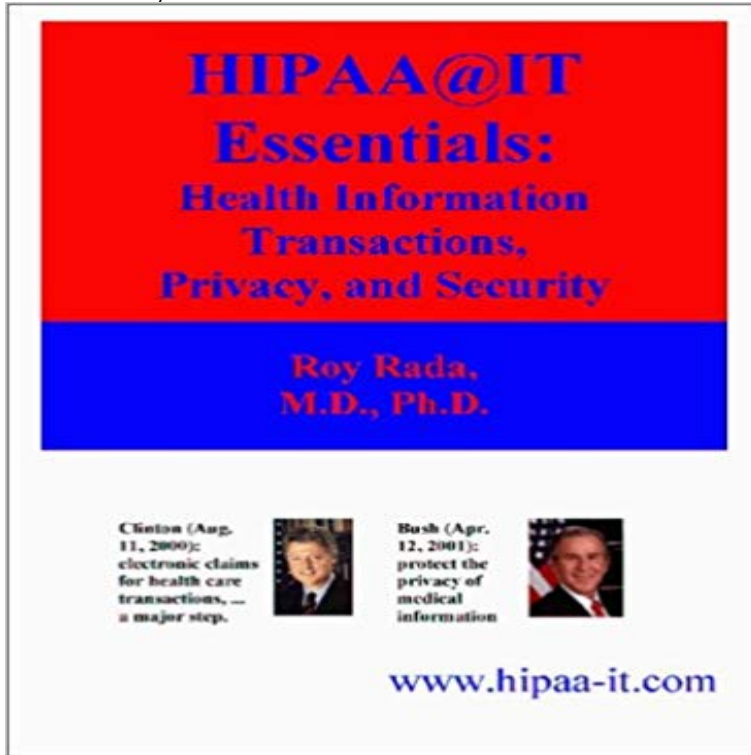


# HIPAA@IT Essentials : Health Information Transactions, Privacy, and Security
