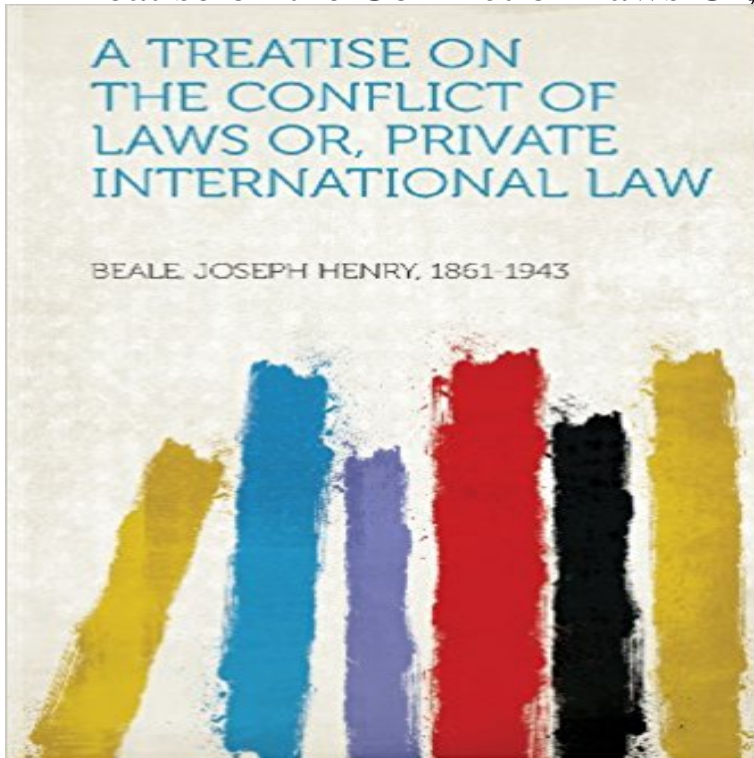


A Treatise on the Conflict of Laws Or, Private International Law
