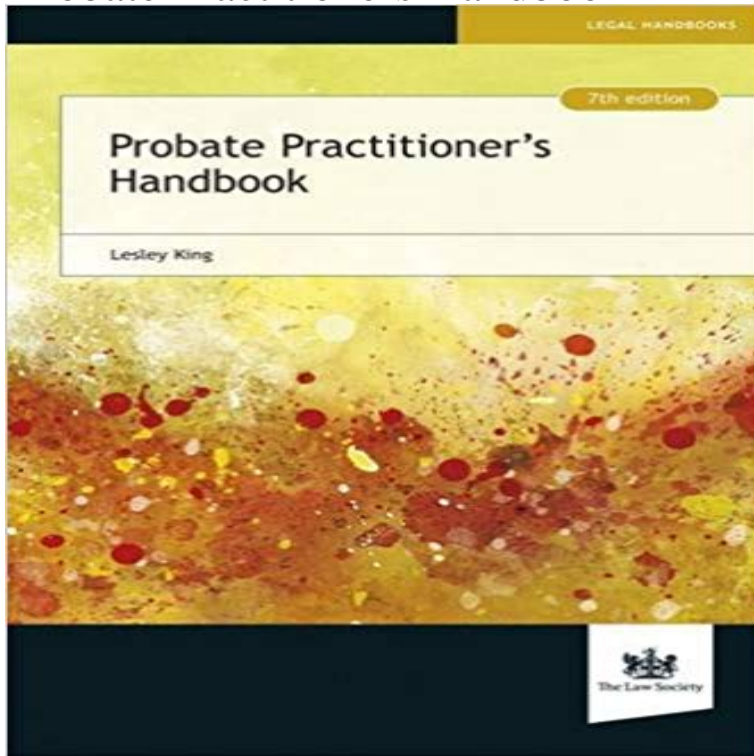


Probate Practitioners Handbook
