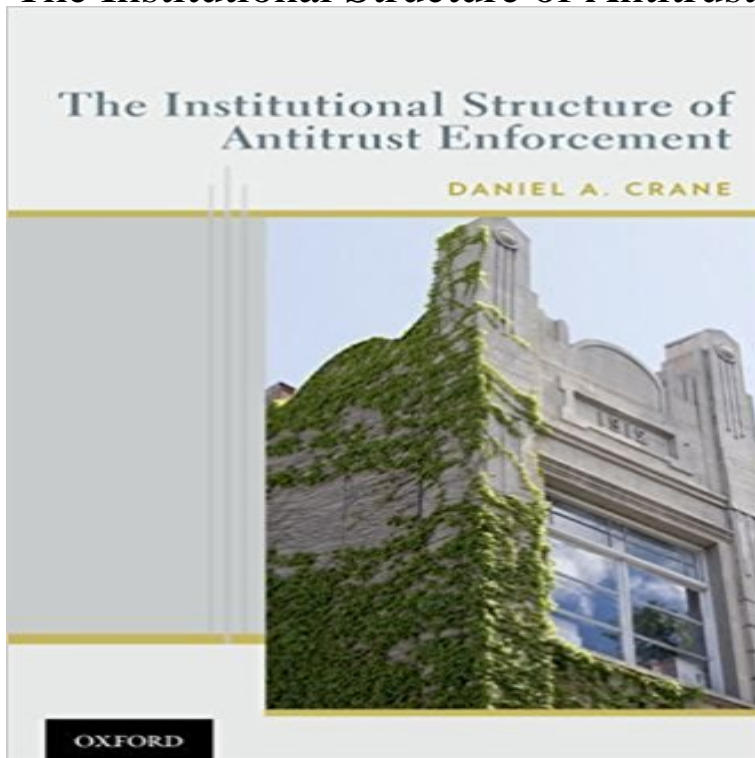

The book derives its topics from historical, economic, political, and theoretical perspectives.
