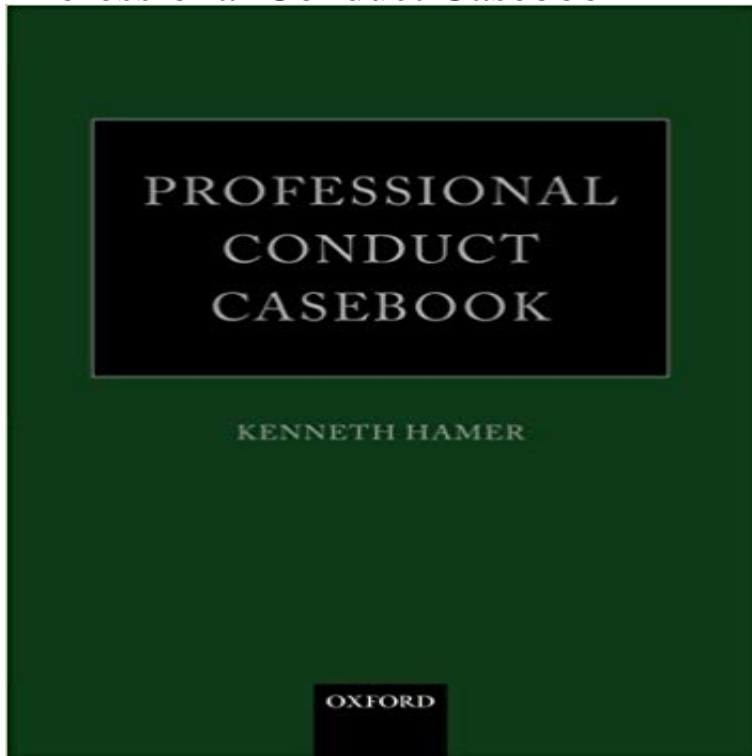


Professional Conduct Casebook
