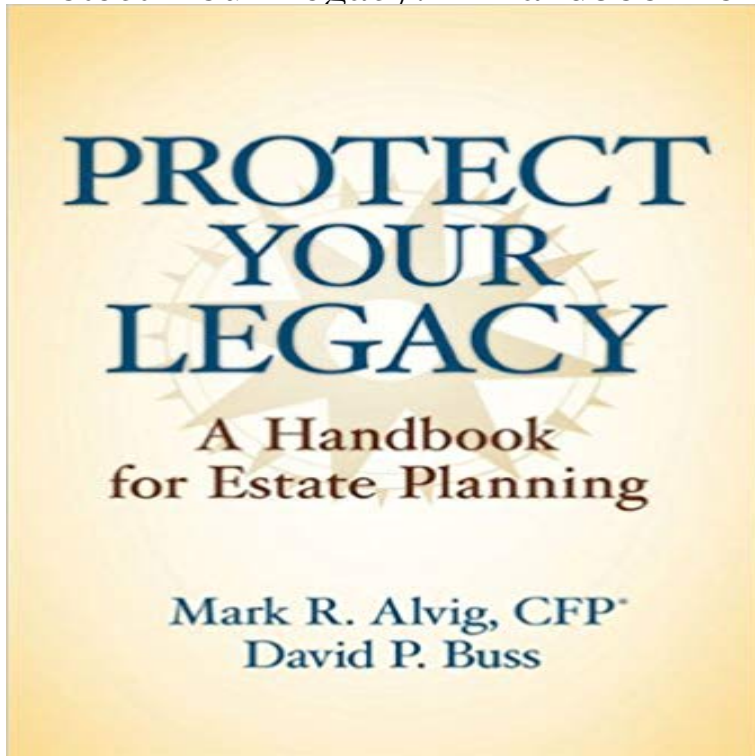


## Protect Your Legacy: A Handbook for Estate Planning
