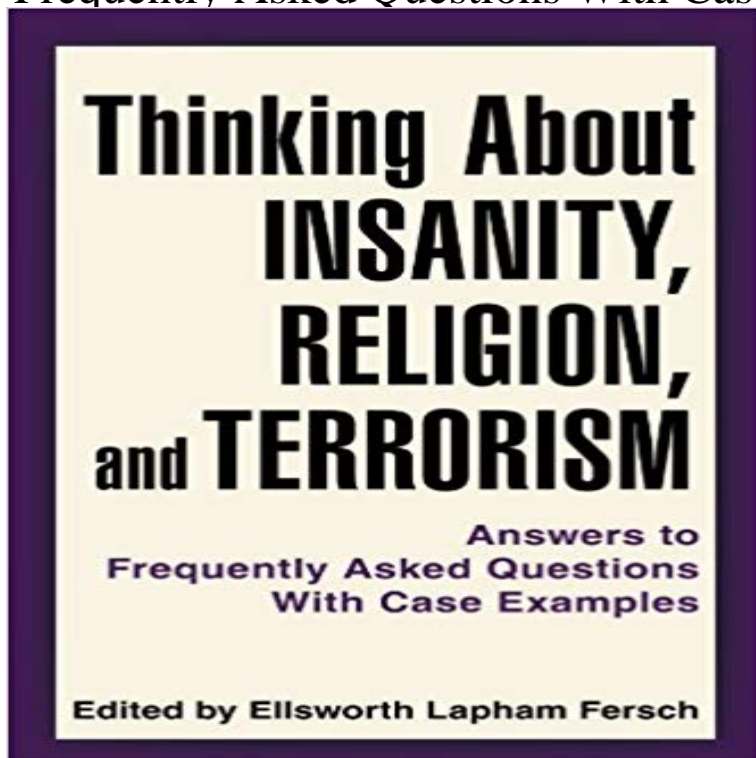


Thinking About Insanity, Religion, and Terrorism: Answers to Frequently Asked Questions With Case Examples
