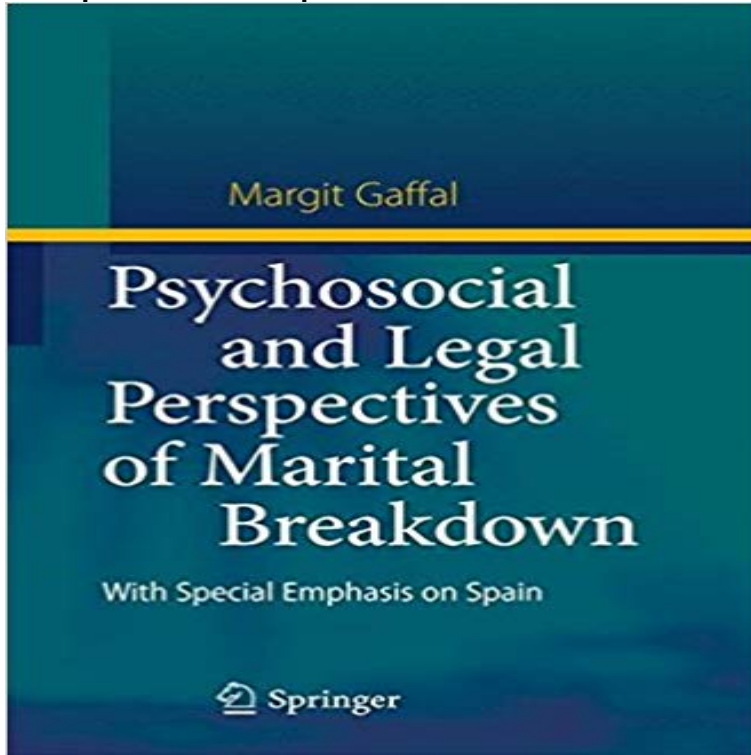


Psychosocial and Legal Perspectives of Marital Breakdown: With Special Emphasis on Spain
