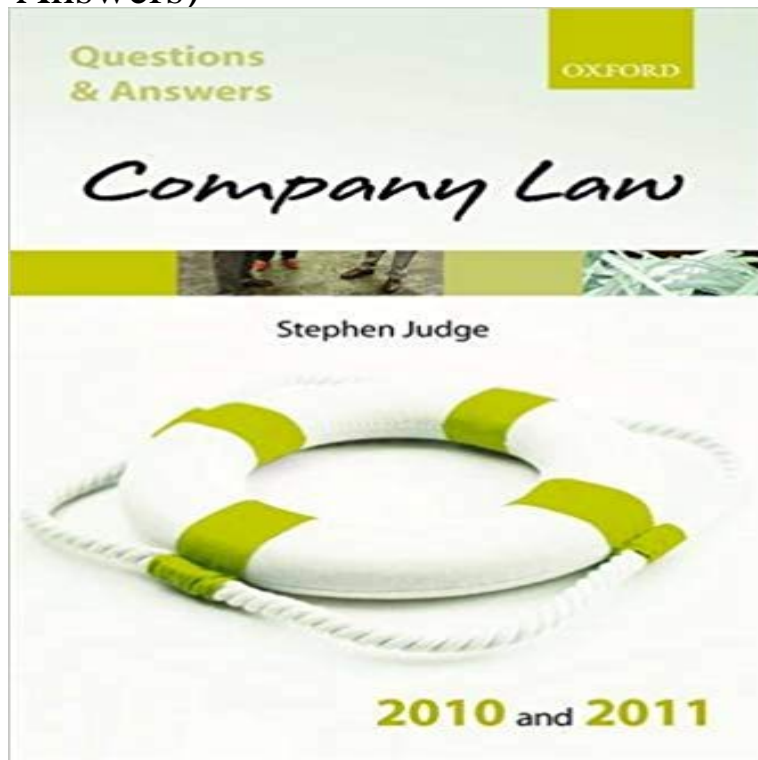


## Q&A Company Law 2010 and 2011 (Blackstones Law Questions and Answers)
