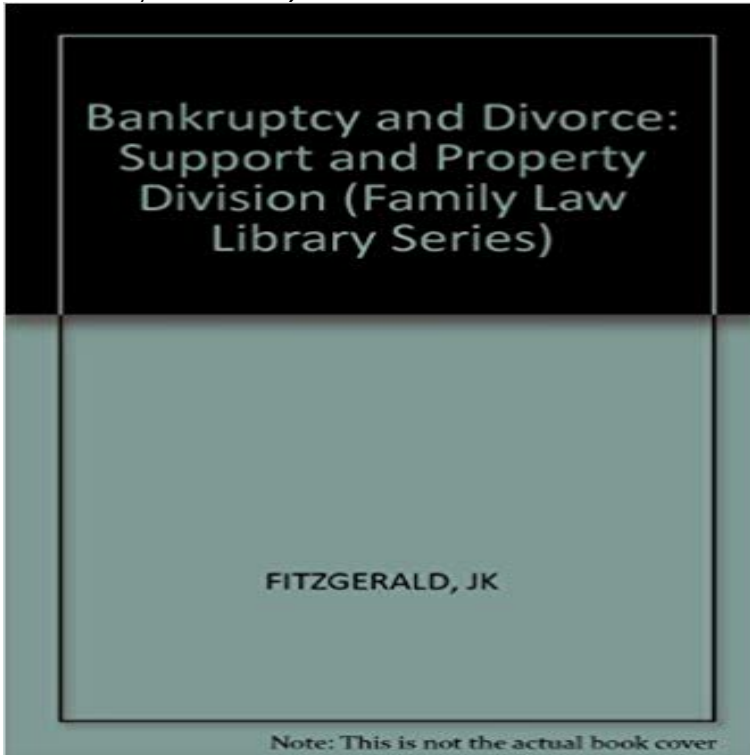


## Bankruptcy and Divorce: Support and Property Division (Family Law Library Series)
