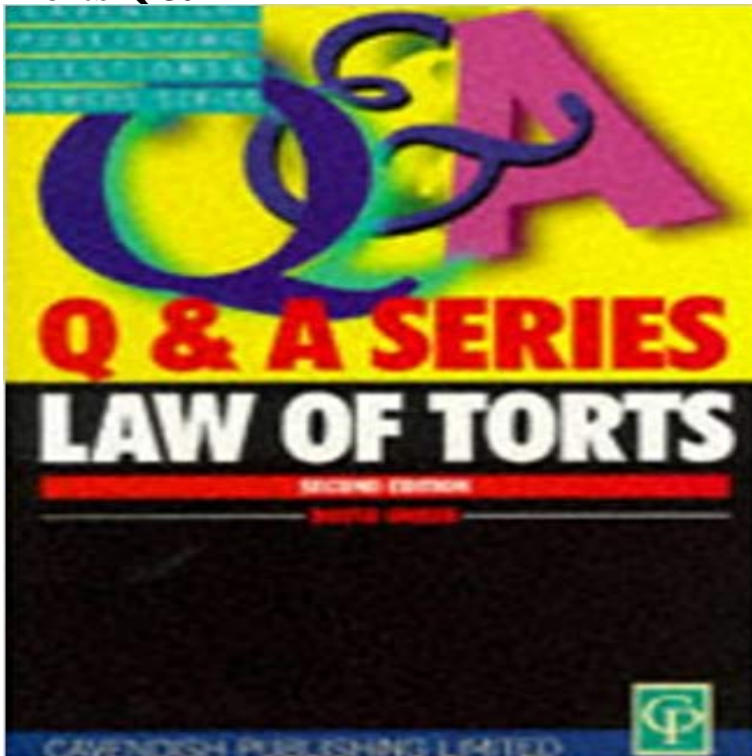


Torts Q&A
