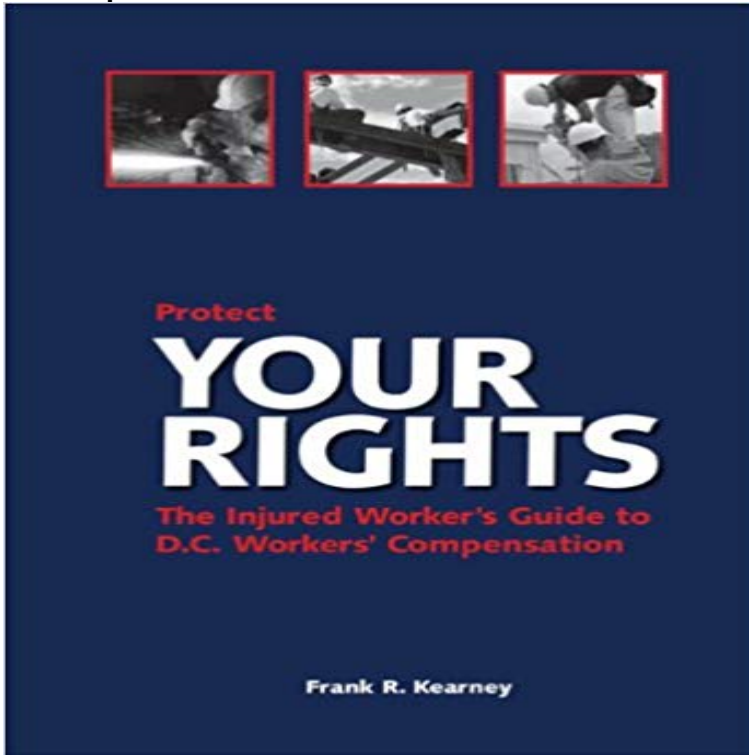


Protect Your Rights: The Injured Workers Guide to D.C. Workers Compensation
