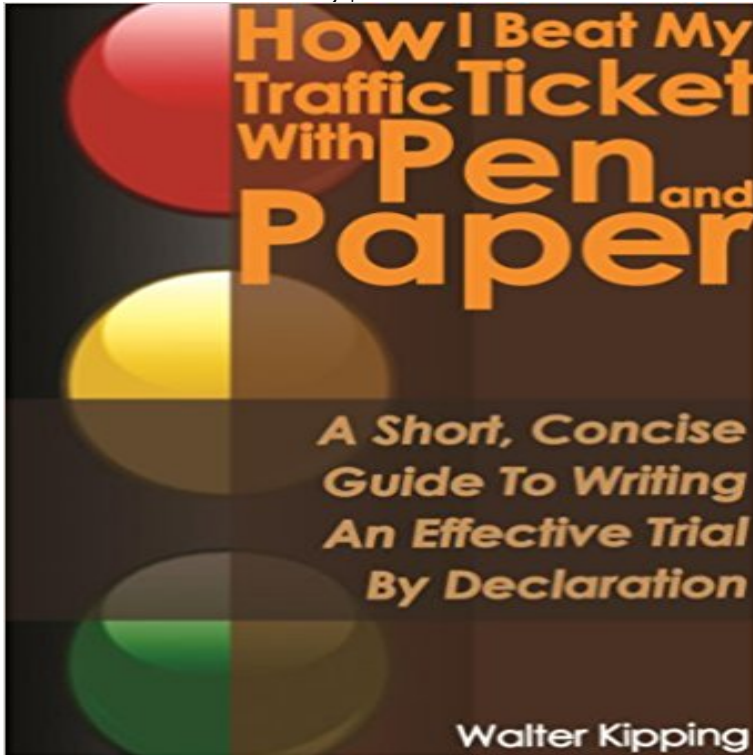


How I Beat My Traffic Ticket With Pen and Paper: A Short, Concise Guide To Writing An Effective Trial By Declaration
