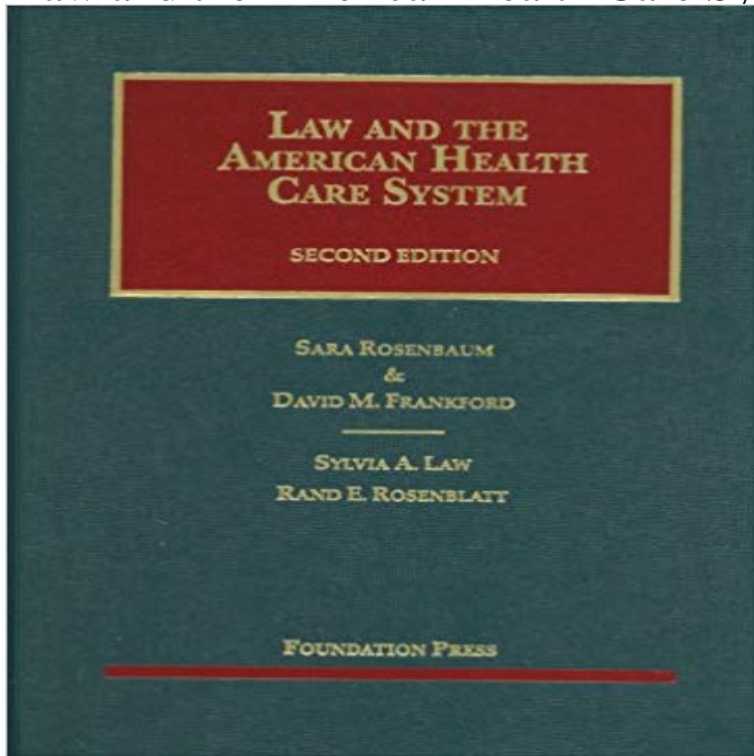


Law and the American Health Care System (University Casebook Series)
