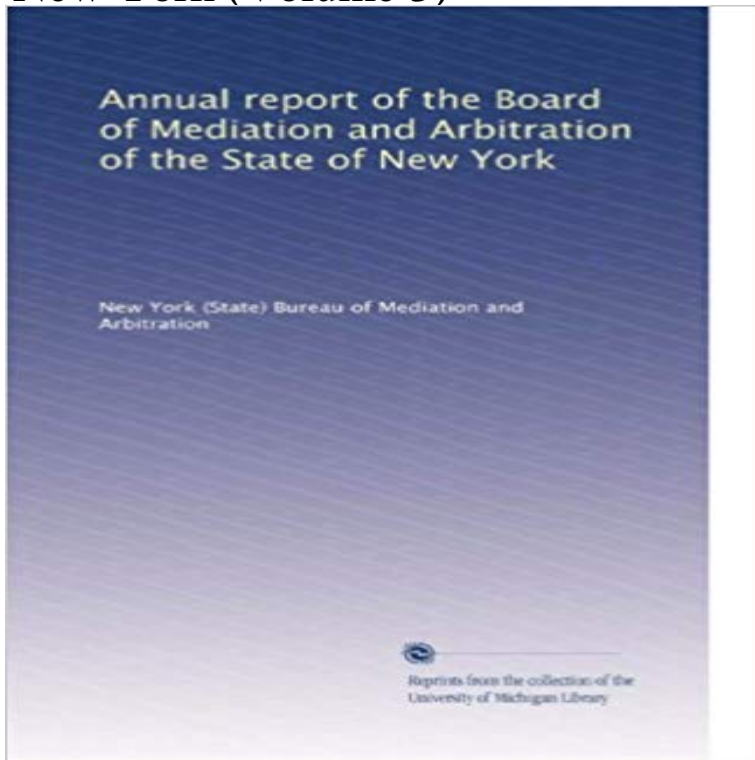


## Annual report of the Board of Mediation and Arbitration of the State of New York (Volume 3)

The witness then read the following letter: In reply to the postal I have received to attend a special meeting November fifth, I have given my resignation to the Working Womens Society on Friday, November second, verbally, to Miss Van Etten. As it has not been brought before the society, I have the honor again of tendering you my resignation to the Working Womens Society. Trusting in your kindness, I remain, Respectfully yours. MARY MAGINLEY. The letter that was written to which this was an answer; the girls, after stopping work at Loewenstein & Grays, went back a few days after they had stopped work for their aprons and scissors, and one thing or another, which they used at their work; Miss Maginley then spoke of the girls using language which was not befitting ladies; and the society of which the girls were members and Miss Maginley was a member requested that they should both appear before the society, and if it was true that this language was used it should be investigated; the girls all appeared; in answer to that this letter was received from Miss Maginley; the resignation was not accepted, and Miss Maginley was expelled. Q. Was it stated by Mr. Loewenstein, in any of the conversations you had with him, that Miss Dugan and Miss Mauror would not be reemployed because they were members of a committee of the society? A. No, sir; I dont think he gave any reason; that was only a personal reason. Q. Have any girls who were in the employ of Loewenstein & Gray been expelled from the society, except Miss Maginley? A. No other. Q. Did Miss Farrar and the others who remained at work resign? A. Yea, sir. Q. Can you give me their names? A. Sarah
