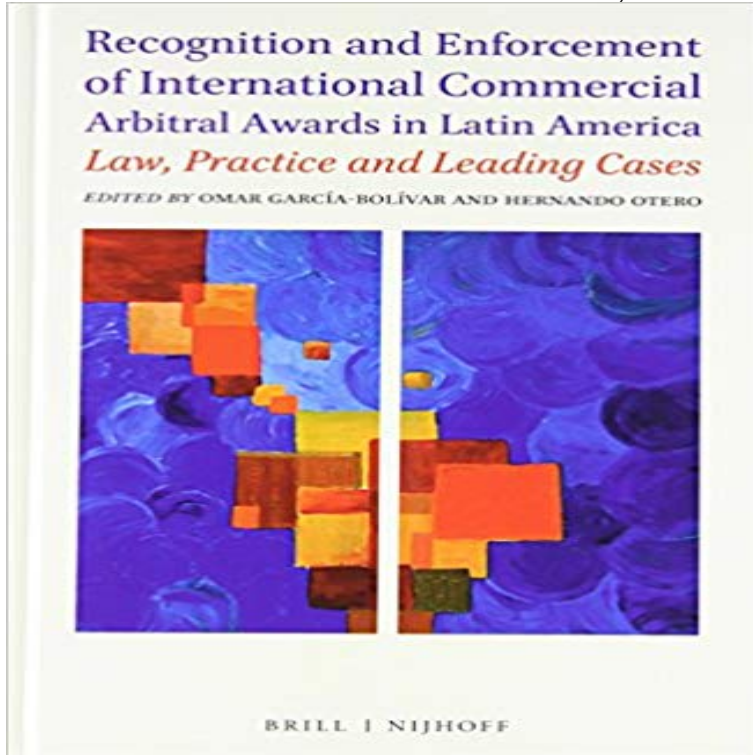


# Recognition and Enforcement of International Commercial Arbitral Awards in Latin America: Law, Practice and Leading Cases
