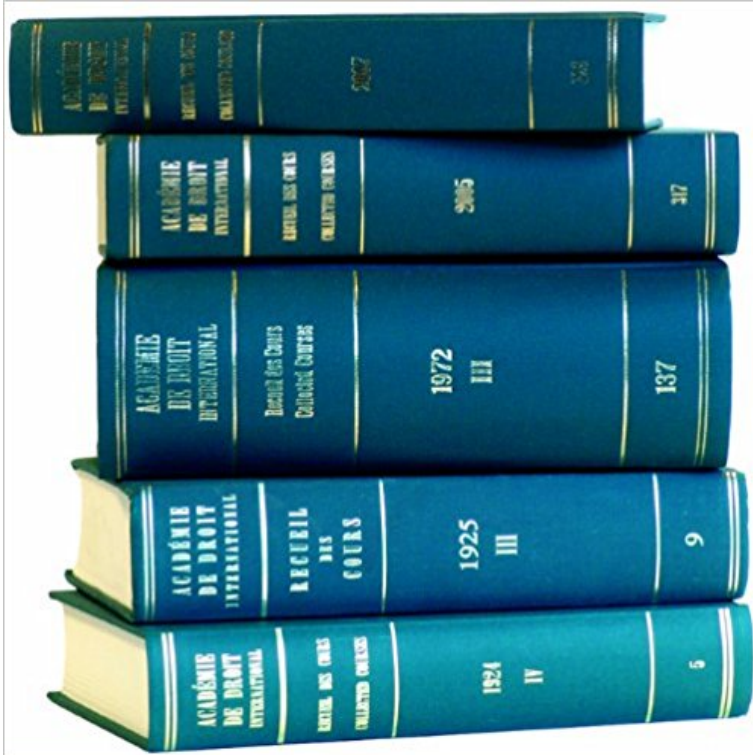


Recueil Des Cours, Collected Courses, 1977 (Recueil Des Cours, Collected Courses)
