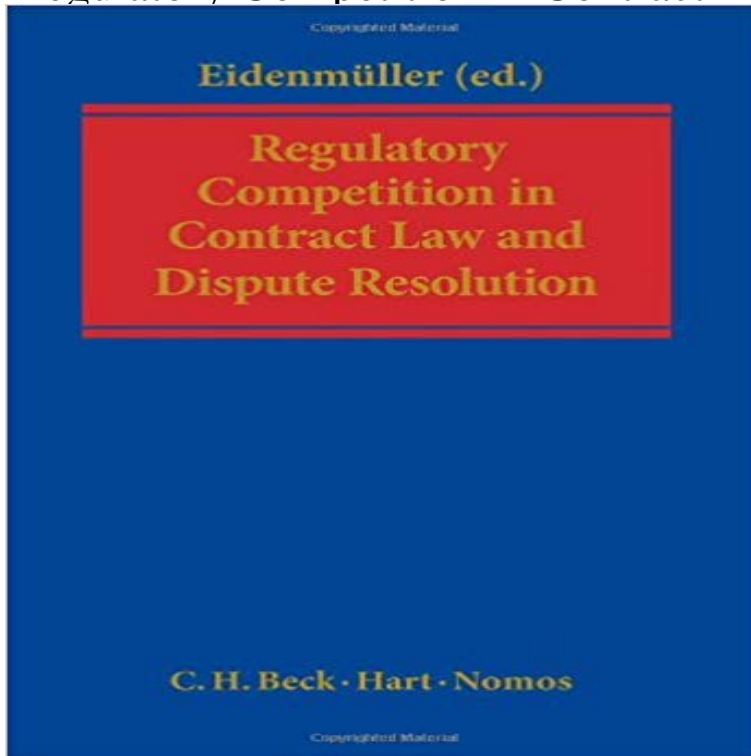


# Regulatory Competition in Contract Law and Dispute Resolution
