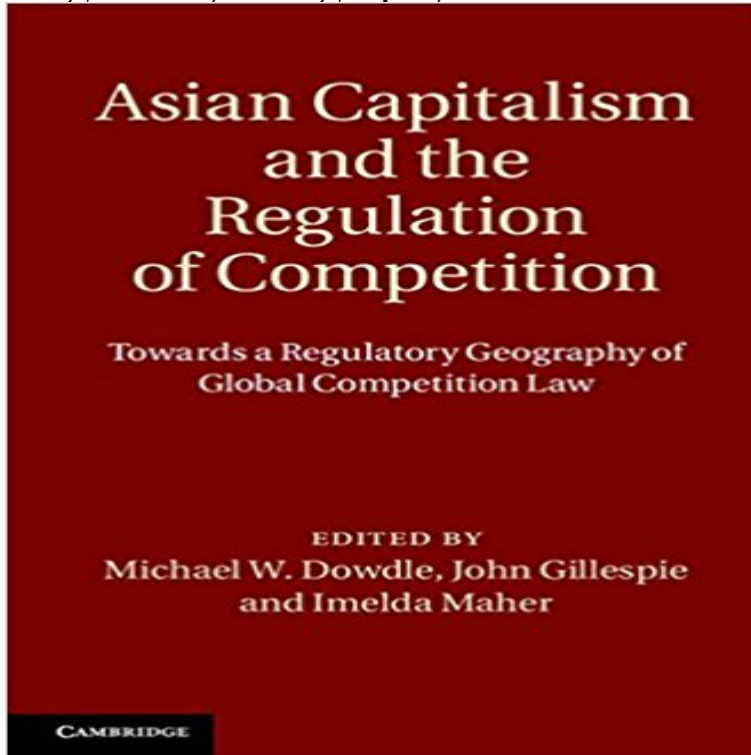


# Asian Capitalism and the Regulation of Competition: Towards a Regulatory Geography of Global Competition Law
