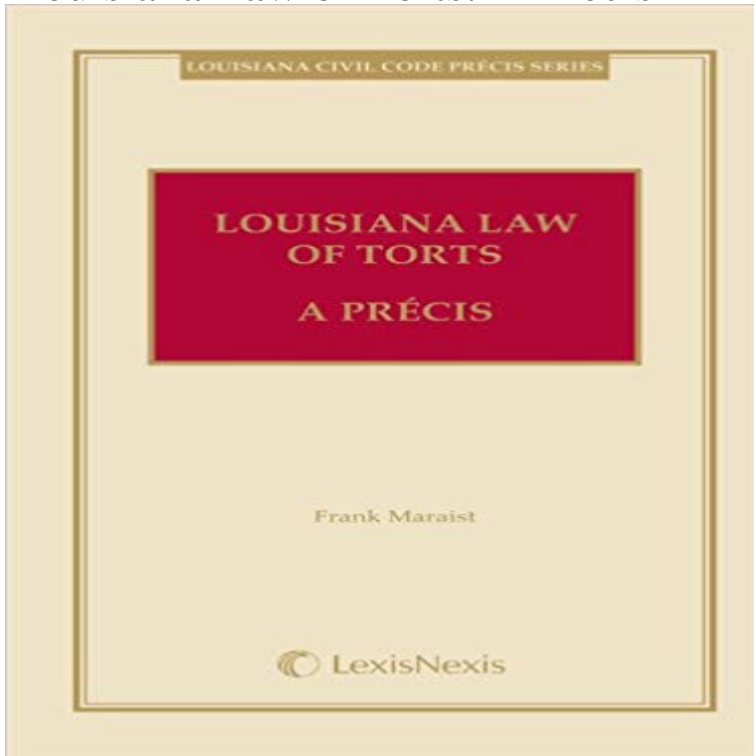


## Louisiana Law of Torts: A Precis

But the concepts these terms embody have their foundations in Louisiana tort law, either through the Code or other legislation or jurisprudence, and from both the common law and civil law influences. For more than 200 years, Louisiana law has been developing under these two influences.
