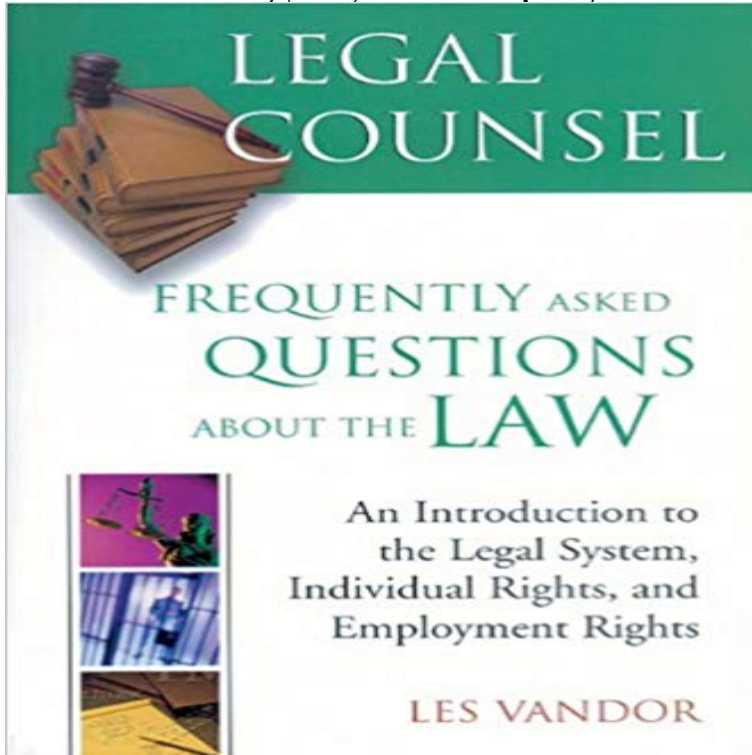


# Legal Counsel, Book One: An Introduction to the Legal System, Individual Rights, and Employment Rights
