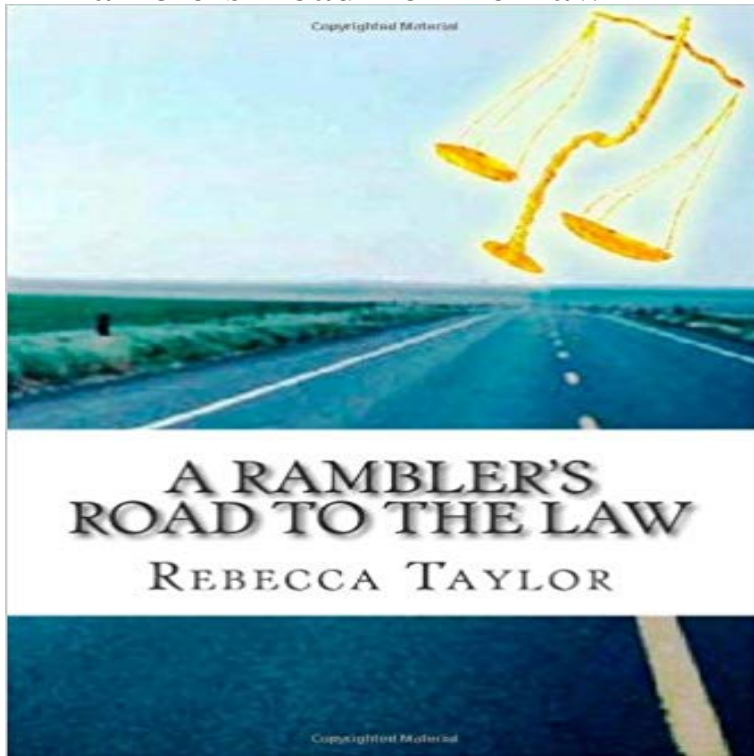


## A Ramblers Road To The Law
