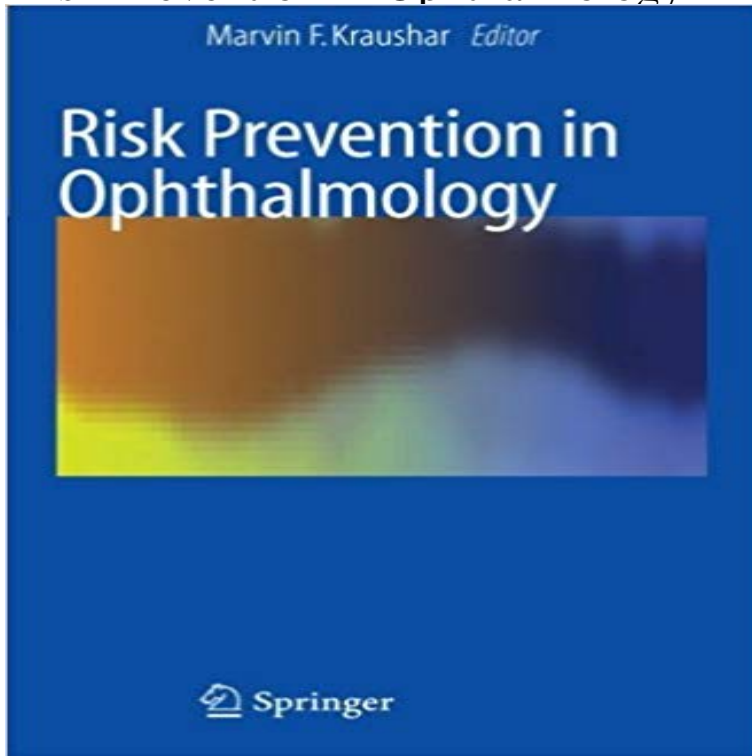


# Risk Prevention in Ophthalmology
