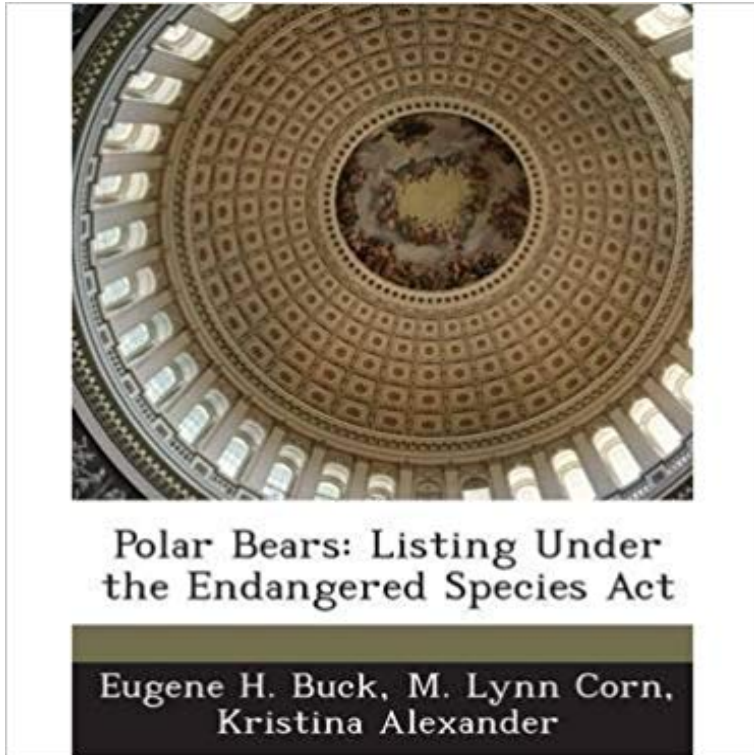


## Polar Bears: Listing Under the Endangered Species ACT (Paperback) - Common
