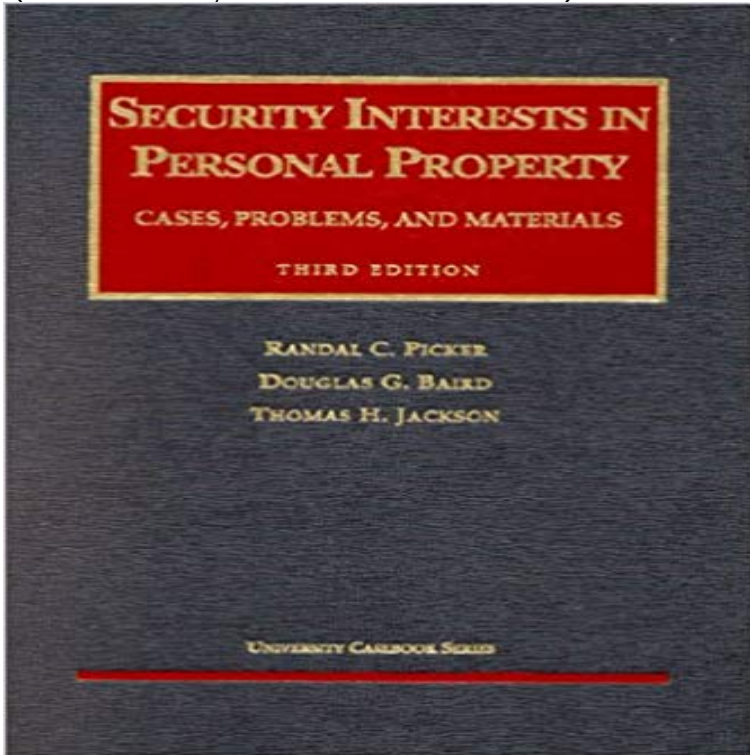


## Security Interests in Personal Property: Cases, Problems, and Materials (University Casebook Series)
