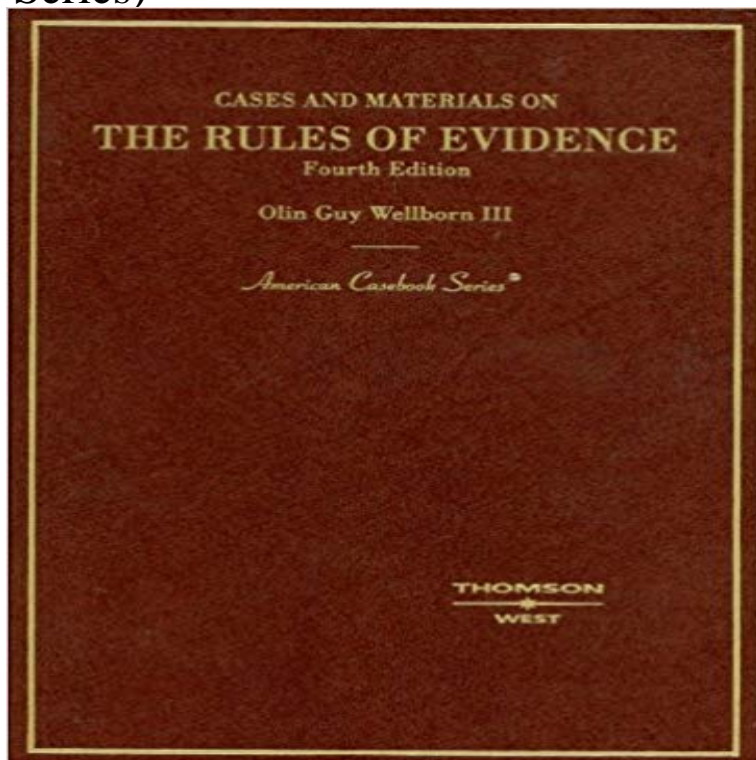


Cases and Materials on The Rules of Evidence (American Casebook Series)
