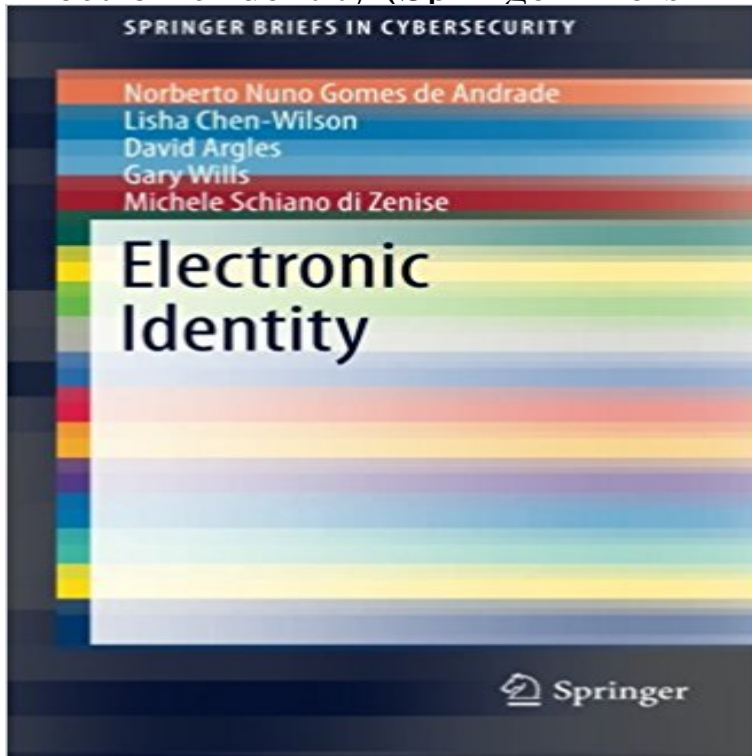


## Electronic Identity (SpringerBriefs in Cybersecurity)
