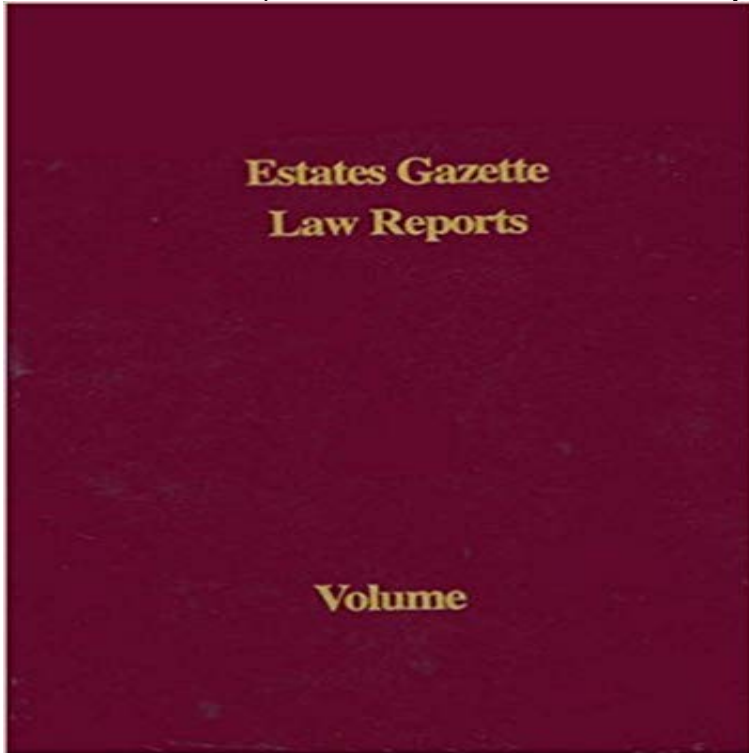


EGLR 2007 (Estates Gazette Law Reports) (Volume 3)
