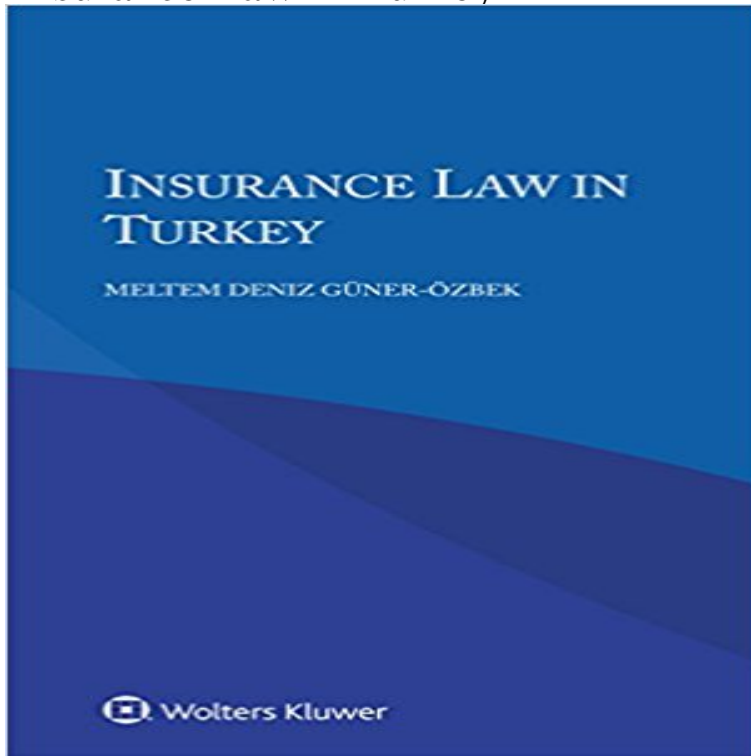


## Insurance Law in Turkey
