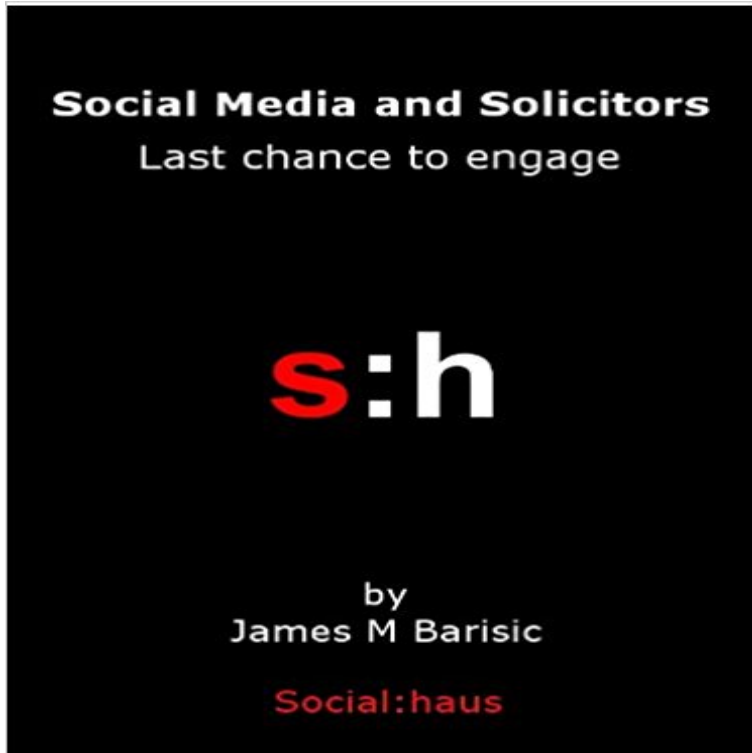


## Social Media and Solicitors - Last Chance to Engage
