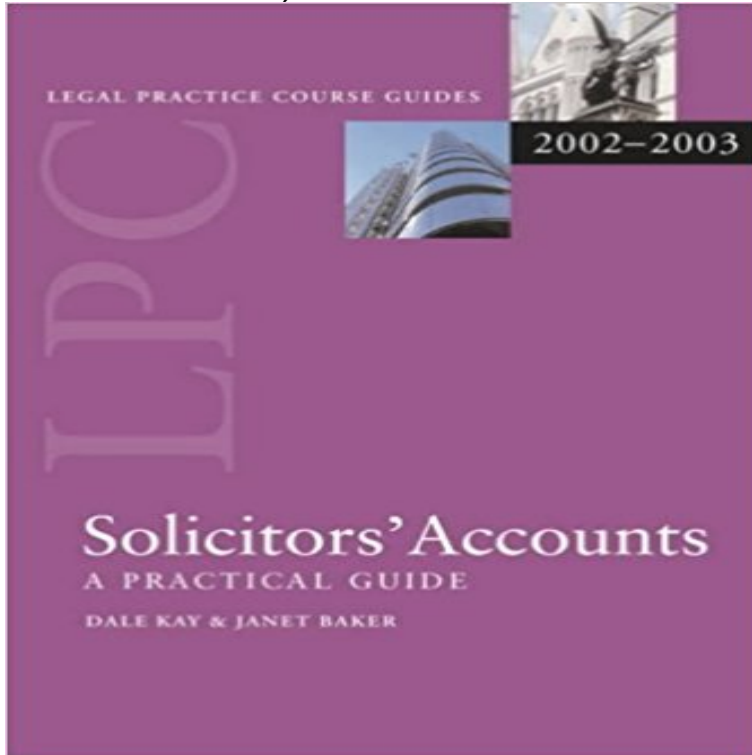


LPC Solicitors Accounts 2002/2003: A Practical Guide (Legal Practice Course Guide)
