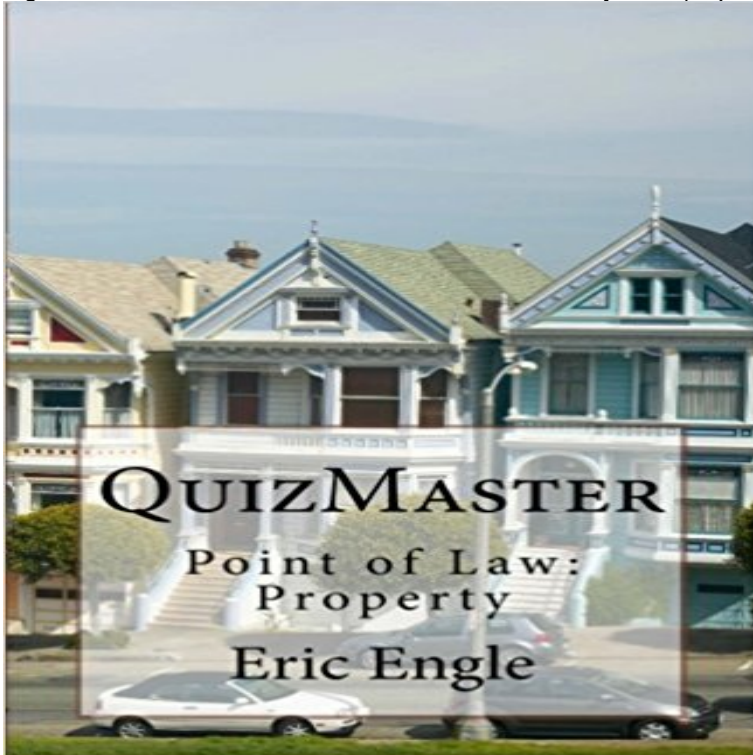


## Quizmaster: Point of Law: Property (Volume 10)
